**H. Ronald Klasko Serves as Program Co-Organizer for  
2017 Invest in America Summit in China**

PHILADELPHIA, PA. May 15, 2017: H. Ronald Klasko, one of the country's top EB-5 immigration lawyers and founding partner of Klasko Immigration Law Partners, recently served as the program co-organizer at the 2017 Invest in America Summit in China. As the largest annual EB-5 conference and trade show held in China, the Invest in America Summit brings together regional centers, developers, attorneys, economists, migration agents, large numbers of individual Chinese investors and Chinese government officials involved with the EB-5 migration program. The summit was held in Shanghai (May 6), Beijing (May 7), Shenzhen (May 12) and Guangzhou (May 13).

Mr. Klasko presented on two subjects in Shanghai and Beijing. One subject was other visa options available to EB-5 Investors. Many Chinese investors are seeking legal ways to spend the long EB-5 quota waiting period in the U.S. and, in some cases, obtain permanent residence through an alternate option. On this panel, speakers discussed mostly L-1 visas, E-2 visas preceded by obtaining citizenship by investment in a country with a bilateral investment treaty with the U.S. and multinational manager immigrant status. Mr. Klasko also presented on a panel involving strategies for dealing with the Chinese quota backlogs. Among other topics, the panel discussed the impacts on job creation; repayment of EB-5 loans and redeployment of the investment funds to keep the investment at risk; changes in the project during the long period of time between investment and condition removal; avoiding aging out of children; and minors as investors; among other issues.

H. Ronald Klasko (Ron) is one of the country's leading EB-5 lawyers. Ron represents thousands of foreign investors from all around the world, over 50 approved regional centers and numerous U.S. developers and business owners who have sought his counsel in connection with using the EB-5 program to raise capital for investment projects.
